PART III - AMENDMENT TO THE BUREAU'S AUDIT GUIDELINES

Para 10.1 – Advertisement contents in a publication

"All advertisements taken by a publisher should appear in all copies of the respective edition / printing centre unless a separate advertisement rate is prescribed and offered for a specific edition / printing centre".

Bureau's Council of Management at its recent meeting decided to **DELETE** the above guidelines from the "Guide to ABC Audit"
