PART – I) Net Realisation Rate (NRR) – July-December 2008:

Reference is invited to para III on the subject of "Net Realisation Rate (NRR)" of Bureau's Notification No. 783 dated 15th November 2007. As you are aware, Net Realisation Rate (NRR) is the term used for value of newspaper in waste per kg. as fixed by the Council from time to time.

Based on the rates of waste newspaper quoted by publisher members, Council adopted the following rates per Kg for all newspaper publisher members for the **audit period July-December 2008 as the Net Realisation Rate (NRR).**

CLARIFICATION TO THE QUALIFYING CRITERIA: [as earlier notified vide Bureau's Notification No. 783 dated 15th November 2007]

Qualifying Criteria

"For each issue on a daily basis the net sale price to the dealer (first point of sale) at any trade margin to be higher than the *net realisation rate (NRR) with a provision to remove "excess circulation" for such issues where **net sale price to the dealer at any trade margin offered is **equal to** / lower than the *net realisation rate (NRR)".

"The same should also be compliant on a weekly average basis for all issues of the week taken together".

(*Net Realisation Rate (NRR) is the term used for value of newspaper in waste computed on the basis of waste rate per kg. as fixed by the Council from time to time).

(**Net sale price to the dealer is the cover price of the publication less applicable trade commission, delivery charges or by whatever name called).
