PART - II - DE-EMPANELMENT OF PUBLISHER AUDITOR – M/S. S.K. GHOSH & CO., CHARTERED ACCOUNTANTS, KOLKATA:

Bureau's Council of Management whilst considering the surprise recheck audit report of "Asomiya Khabar" for the audit period July-December 2012 noted various gross irregularities reported by Bureau Auditors in maintenance of books and records as well as non-adherence to the Bureau's audit guidelines. In spite of such gross irregularities, publisher auditor, M/s. S.K. Ghosh & Co. had earlier certified the circulation figures of "Asomiya Khabar" for the audit period July-December 2012.

Taking the same into consideration, Council decided to de-empanel M/s. S.K. Ghosh & Co., Chartered Accountants, Kolkata with immediate effect.

M/s. S.K. Ghosh & Co., Chartered Accountants, Kolkata will not carry out any circulation audit of member publications pertaining to the audit period January-June 2013 and thereafter.

Result unsatisfactory – circulation figures "Not Accepted" for certification

1) Asomiya Khabar (Assamese Daily), Guwahati & Jorhat editions

Circulation figures in respect of "Asomiya Khabar" (Assamese Daily), Guwahati & Jorhat editions for the audit period July-December 2012 were put through a surprise recheck audit by Bureau Auditors who had reported several gross irregularities in maintenance of books and records as well as non-adherence to the Bureau's audit guidelines.

Accordingly, circulation figures in respect of "Asomiya Khabar" were treated as "**Not Accepted**" for certification for the audit period July-December 2012.
